

## Public Service Loan Forgiveness

### FAQ

#### What is Public Service Loan Forgiveness (PSLF)?

- PSLF is a loan forgiveness program for Federal Direct student loans. It forgives the remaining loan balance of borrowers who make 120 eligible payments while employed full-time by an eligible employer such as a 501(c)(3) non-profit employer.

#### How do I qualify?

- Service within the Hospital Co family of organizations may qualify you for Public Service Loan Forgiveness (PSLF) while working full-time in your present or past role(s).
- Register your Tuition.io account & link your student loan(s) to your account.
- Use the Strategy Finder on Tuition.io to get your loans on the right track for PSLF and determine the eligibility of those loans.
- If eligible, submit your PSLF form using Tuition.io's convenient web-based PSLF form.

#### How do I apply/register? (URL & registration info)

- Visit [nemours.tuition.io/register](https://nemours.tuition.io/register) and request an email invitation to participate by entering your work email address.

#### How can I get additional support?

- Tuition.io offers support in the form of technical assistance as well as one-on-one student loan coaching. Both are directly accessible from your Tuition.io account.

#### If I am already enrolled in the PSLF program can I still use Tuition.io?

- Yes! Even if you already took care of PSLF this year you can still enroll through Tuition.io to begin experiencing PSLF digitally through the software and email reminders to keep you on track.

#### If my employment does not qualify, can I still use Tuition.io as a student loan debt solution?

- Yes - you can absolutely still use Tuition.io's resources and loan coaches even if you are not PSLF eligible or don't have student loans currently.

#### If I have employment with another employer, how can I have that employment verified through Tuition.io?

- During the PSLF form steps, you'll be asked if you want to have the form issued to your current or former employer.

**What is the process for PSLF form submission for Children's Health Alliance a "pass through entity"?**

If you are interested in pursuing PSLF your PSLF form submission steps are different. Please review the steps below.

- Complete the PSLF form via the Dept of Education PSLF tool
  - <https://studentaid.gov/pslf/>
- Upload the Nemours documentation to the Dept of Education PSLF Help Tool
  - Documentation confirming the pass-through organization's status as a disregarded entity, a statement of the owner organization's eligibility and its Federal EIN

  - A copy of your W2 showing the EIN for Children's Health Alliance

**PSLF form review typically takes the Dept of Education 90 days from receipt.**

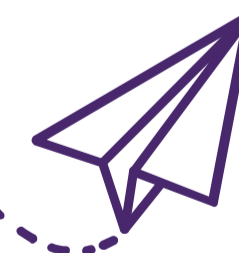
